- For all other posts: The final merit list will be prepared based on the marks obtained in mains exam only for all categories (i.e. UR, OBC, SC, ST, EWS, PwBD etc.) separately and rank will be awarded to all qualified applicants. While preparing the merit list for the UR, all applicants (including those from the reserved categories) will be taken into consideration based on merit, but while preparing the merit list for a reserved category, only applicants of that category will be taken into consideration. The same method will be applicable in all reserved categories.
