Dr. Ram Manohar Lohia Institute of Medical Science (RMLIMS), Gomti Nagar, Lucknow announces admission to full time M.Sc Nuclear Medicine for the Session 2026-2027. The M.Sc Nuclear Medicine at RMLIMS is approved by AERB, Mumbai.

Candidates who have obtained their qualifying degree through correspondence courses are not eligible. Candidates who have undergone B.Sc training in other imaging courses are also not eligible. Further 5% relaxation is permitted to reserved category candidate having domicile of Uttar Pradesh. Note: Candidates must possess, a requisite qualification RECOGNISED by the respective bodies that approve the qualifying course as on 31st Dec, 2025 |

Eligibility Criteria

Applications are invited for admission to M.Sc Nuclear Medicine at Dr.RMLIMS for academic year 2026-27. The candidates must possess a requisite qualification as on 31st Dec, 2025. The degree from Departments/ Institutes to which recognition has not been formally granted (For example: under consideration) will not be considered and candidature of applicants with such degrees may be rejected at any stage (including after admission if this fact comes to notice at that stage).

Nationality: Only Indian nationals (irrespective of gender) are eligible.

Age: Minimum age should be 17 years and upper age limit is 35 years as on 31st Dec, 2025.

Reservation: Reservation will apply as per U.P Government rules for candidates having domicile of Uttar Pradesh only. Reserved category candidate having domicile other that Uttar Pradesh will be treated as General category for all purposes.

Reserved category candidates should produce an authentic certificate of their category, issued by a competent authority.

Application fee: Application fee for General/EWS/OBC is Rs. 1000/-, for SC/ST is Rs. 600/- (including GST). Bank draft will not be accepted.

Method Of Selection: Admissions M.Sc. courses are to be made through entrance examination conducted by the Institute. The Entrance Examination will be with a total of 100 marks (100 questions).

Counselling: All the qualified candidates those appeared in the entrance test for admission to M.Sc Nuclear Medicine course have to appear in the counselling as per the procedure laid down by the Institute.

Qualifying marks: Candidates are required to obtain following minimum marks to qualify the test / Examination:

HOW TO GET YOUR ADMIT CARD: Eligible candidates can print their Admit Card ONLINE to appear in the entrance examination between prescribed dates using their email ID, password or as per the process mentioned on the web portal.

EXAMINATION RESULT: The list of eligible candidates called for counselling and the final result of entrance examination will be displayed on the Institute's website.

Important Instructions:

Filling and submitting the application form only makes you eligible to appear in the entrance examination. Admission in the course is subject to verification of the essential documents of the qualified candidates at the time of counselling. Selection of the students by the entrance examination conducted by the institute will be followed by counselling as per institute norms. Candidates attending the counselling need to bring all original documents for verification and come prepared for fee payment and admission which will be done immediately as described below:

IMPORTANT INSTRUCTIONS FOR ADMISSION & FEE PAYMENT

- 1. The selected candidates after counselling are required to pay the first instalment of the first year within the stipulated time. Their original certificates will be deposited with the Institute. Only after the receipt of the fees of the 1st semester, admission will be considered against that particular seat. Failure to complete registration formalities will lead to cancellation of the selection and the seat will be offered to the next wait-listed candidates.
- 2. Thereafter, the fee will have to be paid on a six-monthly basis, as per the academic schedule. Part payment of the term fee will not be entertained. The prescribed fee should be paid within 1 month of the commencement of each term.
- **3.** The examination fee as prescribed will be notified before each examination.
- **4.** All the candidates must pay the refundable Caution Money as specified in the fee chart. The same will be refunded when the student leaves the Institution after completion of the Course.
- **5.** The examination fee is not refundable either in full or part under any circumstances.
- 6. **JOINING:** If a candidate fails to join the course by the date stipulated in the selection letter, the offer shall automatically stand cancelled, and the seat will be offered to the next candidates in the waiting list in order of merit and Eligibility. At the time of joining, the selected candidates shall have to submit their original Matriculation certificate, Intermediate (10+2) passing certificate/B.Sc. passing certificate, caste & domicile certificate in case of reserved category candidate, Migration Certificate and certificate of good conduct by two gazette officers.
- 7. **Medical Examination:** No candidate will be permitted to join a course unless declared medically fit by the Medical Board constituted by the Institute for the purpose. The decision of the Medical Board shall be final.
- **8. FEE:** Each student will have to pay the following fees inclusive of tuition, library, laboratory, examination fees, etc.

- Hostel Facility is subject to availability.
- Any other expenses (TLD Batch, Dress, Books, Study material & Mess etc) shall be borne by the students.

Other Important details

- **PAYMENT OF FEES:** Fees for the first instalment will be payable at the time of joining, 2nd instalment in July and that for subsequent years in January & July or within 15 days from the start of the session/ semester. The candidates will not be permitted to join the session/course without payment of the requisite fee.
- **DUTIES AND RESPONSIBILITIES:** Students admitted to the courses shall be required to perform such work as may be assigned to them and are necessary in the legitimate interest of patient care, teaching, training, research and in Emergency services as and when required.
- **DURATION OF THE COURSE:** The entire curriculum of M.Sc Nuclear Medicine Course is split into semesters of 6 months' duration each, and semester examinations will be held on a 6 monthly basis.
- 4 | SALARY: No salary will be paid during the course.
- **HOSTEL ACCOMMODATION:** The hostel facility is extended to outstation candidates, but not guaranteed since it is subject to availability as per Institute norms. In case of continued poor progress, the students may be asked to leave the hostel, if allotted.
- 6 LEAVE ENTITLEMENT: The students will be normally entitled to following leaves:
 - 1. Winter Break: 10 days in December
 - 2. Summer break: 10 days in June
 - 3. Sick Leave: 10 days/year

Other leaves: subject to achieving 80% attendance in theory classes and practical individually which is essential to be allowed to appear in the semester examination. Deficiency in attendance, if any, is to be made up in the vacations.

7 LEAVING THE COURSE / WITHDRAWAL RULES:

Students registered for and admitted to a course, desirous of obtaining their original documents from the Principal / Dean to attend interviews elsewhere, should have deposited the 1st semester year fees as mentioned above. b. Students who fail to inform their decision to continue or withdraw from the course, the UGC rules for fee refund mentioned below will be followed:

- 8 If the candidate wishes to continue, he must inform the competent authorities and re-submit original certificates.
- Aspiring applicants satisfying eligibility criteria in all respects can submit their ONLINE application only. Online application (s) link will be available on Institute's website.
- The final decision for admission to the course will depend based on document verification at the time of counselling. Any false information filled at the time of ONLINE application will be the sole responsibility of the student and they themselves will be responsible for rejection of thier candidature.
- 11 The decision of the Institute in respect of eligibility & suitability of a candidate shall be final.
- 12 The date, time and venue of the examination will be provided on the admit card.
- 13 No TA/ DA shall be paid for appearing in the entrance examination or for joining.
- Any attempt on the part of a candidate to suppress facts, provide false information or influence the admission directly or indirectly will be treated as a disqualification, and if selected, his admission will be cancelled.
- Each selected candidate shall have to pay the fee/ dues within the prescribed period, failing which his/her admission shall be cancelled
- The training programs are full-time and continuous, and private practice in any form after joining the Institute is strictly prohibited.
- All students admitted to the Institute shall maintain good conduct, attend their classes regularly and abide by the regulations/guidelines of the Institute failing which their names are liable to be struck off the rolls of the Institute.
- Participation in any agitation, protest, strike, etc. is prohibited. Candidates not abiding by these provisions are liable to be terminated
- Ragging is strictly prohibited. If any incident of ragging comes to the notice of the authority, the concerned student shall be given the liberty to explain and if his/her explanation is not found satisfactory, the authority would expel him/her from the Institute.
- No intimation to non-selected candidates will be sent and no correspondence on this subject will be entertained.
- These rules are subject to change in accordance with the decisions of the Institute, taken from time to time.
