Subject: Approval of the decisions taken in 18th meeting of Academic Council held on 14th May, 2024.

The Board of Governors in its 40th meeting held on 17.09.2024 deliberated on the agenda no. (16) regarding approval for the decisions taken in 18th meeting of Academic Council held on 14th May, 2024.

The Board has reviewed the Sub-agendas and after due deliberations, decisions are as under-

Sub-Agenda No.	Decisions of the Academic Council.	Decision of the Board.
40/16(A)	Commencement of 11 New Courses in PDCC and 3 new courses in PDF.	The Board deliberated on the matter and opined that the commencement of PDCC and PDF in new specialties/super specialties is good for the Institute and students. The Board ACCORDED ITS APPROVAL for starting these new PDCC/PDF courses.
40/16(B)	Rules for Post-Doctoral Certificate course (PDCC) and Post-Doctoral Fellowship (PDF) Courses. The Board was apprised that these rules have already been framed and approved by the 18 th Academic Council meeting on 14.05.2024.	The Board deliberated and ACCORDED ITS APPROVAL for the rules for PDCC/PDF course at the Institute.
40/16(C)	Starting of Ph. D Program in the Institute. The Board of Governors was apprised that the rules for the PhD program at the Institute were already approved by the previous Board of Governors. A proposal for few modifications in the already approved rules were presented before the Board for its kind approval: 1. Extramural funding for PhD research work should be desirable but not mandatory. 2. Non-NET qualified candidates wishing to pursue PhD on self-finance mode should be allowed after	The Board deliberated on the proposal and ACCORDED ITS APPROVAL FOR POINTS (1) AND (2) INITIALLY FOR A PERIOD OF 3 YEARS regarding extramural funding for PhD and PhD in self-finance mode respectively. However, the Board decided that no students in self-finance mode should be granted stipend and the criteria regarding minimum research paper publications approved earlier by BOG should not be diluted; accordingly, the Board decided NOT TO ACCORD ITS APPROVAL FOR POINTS (3)

40/16(E)	The Board was requested to accord approval for amendment of some inadvertent errors in previously approved Academic fee of MBBS courses & proposal of fine for late deposition of academic and hostel fees.	The Board deliberated on the proposal and ACCORDED ITS APPROVAL.
