Sir /Madam,

I am directed to convey the approval of Board of Governors in supersession of Medical Council of India for renewal of permission for admission of 3<sup>rd</sup> batch of 150 (one hundred fifty) MBBS students at Dr. Ram Manohar Lohia Institute of Medical Sciences, Lucknow, Uttar Pradesh u/s 10A of the IMC Act, 1956 for the academic Year 2019-2020. The Board of Governors has granted approval after consideration of the Compliance Verification Assessment Report (8<sup>th</sup> April, 2019) along with the summary/observations of the member of the Undergraduate Expert Group appointed by the Board of Governors.

2. The Permission is valid for one year and for admitting only one batch of 150 students during the academic year 2019-2020. The next batch of students in MBBS course will be admitted in the college only after permission of Board of Governors in supersession of the MCI for renewal/recognition.

3. The Government Medical Colleges (except those located in J & K States) shall contribute 15 % of MBBS seats for which the renewal permission is granted for all India quota.

4. Admissions made in violation of the above condition will be treated as irregular and action will be initiated under IMC Act & Regulations made there under.

5. Discrepancies, if any, may be immediately brought to the notice of the Board of Governors in supersession of the MCI and the State Govt.


Subject: Reservation for Economically Weaker Section (EWS) for admission in Medical Education Institutions under Constitution Amendment (One Hundred and Third Amendment) Act, 2019 dated 12.01.2019- Increase/decrease of seats, which was earlier increased under EWS Quota for the academic year 2019-20- Reg.

Madam/Sir,

In continuation to this Department's letter of even number dated 21.06.2019, I am directed to refer to the BoG-MCI's letter No.MCI-34(41)(EWS)/2019-Med./126765-66 dated 29<sup>th</sup> June, 2019 submitting revised proposal to the Ministry containing the names of Medical Colleges with permitted MBBS seats and decrease of seats in certain cases which were earlier increased vide Ministry's letter dated 21.06.2019 under EWS quota for 2019-20.

2. After carefully considering the matter, Ministry of Health & Family Welfare has accepted the proposal of the BoG-MCI and hereby directs the Counselling Authorities (States/UTs/AIQ) for filling up the newly created MBBS seats under EWS quota as per rules in forthcoming academic year 2019-20 mentioned in attached Table A and also directs to delete the seats in certain cases which were earlier increased vide Ministry's letter dated 21.06.2019 mentioned in attached Table B. **CLARIFICATION REGARDING AVAILABLE SEATS FOR  
COUNSELLING AFTER IMPLEMENTING EWS QUOTA IN  
MBBS COURSE.**

The Commission is in receipt of several queries regarding the seats granted for implementing the EWS quota. The clarifications to the queries are as below:-

1. As per guidelines of MoHRD & MoHFW for implementation of 10% EWS quota, the medical colleges recommended by State/ UT Govt. /Central Govt. Institutions were granted one time increase in MBSS seats during AY 2019-20 and AY 2020-12. This increase in seats granted to implement the EWS quota does not require annual renewal permission as is required for seats granted under section 10A of the IMC Act, 1956 read with section 61(2) on the NMC Act, 2019. However, the increase in seats so granted would require to be recognised when the batch admitted against the increased seats appear for their final MBBS -III (Pt.2) University examination. ①
2. It is further clarified that the increase in seats granted to implement 10% EWS quota will be part of the total MBBS seats available for admission and all the various quota like AIQ, State Quota (including EWS, SC, ST, OBC and other reservations) will apply to the total MBBS seats. ②



3. It may be noted that for any Medical College which has been granted LoP for increased intake in MBBS seats for the AY 2020-21, the total seats also include the increased seats granted earlier for AY 2019-20 for implementing the EWS quota. For example, if a college had been granted permission to increase seats from 100 to 125 during academic year 2019-20 for implementing EWS quota and was granted permission to increase from 100 to 150 seats under section 10A for AY 2020-21, the total seats will remain capped at 150 annual intake and not 175.
