

Recruitment Notice for World Bank Project

Applications are invited from Indian Nationals for the following short-term posts for the World Bank funded research project entitled "Assessment of Lead Poisoning in Uttar Pradesh" under Prof C M Singh, Director (Principal Investigator), Dr. Ram Manohar Lohia Institute of Medical Sciences, Lucknow for variable periods mentioned against each post. The aim of the project is evaluation of lead exposure through testing of Blood Lead Levels (BLL) of pregnant women and children in Uttar Pradesh. This would involve collection of data & blood samples at community level from the selected areas spread across the state of Uttar Pradesh and safe transport of data and samples to Dr RMLIMS, Lucknow for testing. This job would provide an opportunity for working with experienced faculty and learning in field.

The above posts will be filled purely on a temporary basis, co-terminus with project. The candidate will have NEITHER right to claim permanent employment under this project or for continuation of his/her services in any other project, NOR any claim for permanent/ regular/ contractual/ any other employment under Dr RMLIMS, Lucknow.
