#### **TENDER DOCUMENT**

#### 1. Bidder's Eligibility Criteria

The Bidder should meet the following criteria:-

- I. The bidder should be registered with Goods & Services Tax, Department of Govt. of India and have other mandatory registration such as PAN/ TAN etc.
- II. The bidder should have core competence in providing SPECT-CT Generator/Radio Pharmaceutical Products per guidelines of AERB and have all mandatory permissions & NOC etc for the same.
- III. The bidder should have an average annual turnover of Rupees 1 Crore (**One Crore**) during in last 3 financial years (2021-22, 2022-23& 2023-24). COT duly signed by CA is must.
- IV. The bidder should not have been blacklisted in last three years. A non-blacklisting/ conviction certificate duly notarized on Rs.100/- Non judicial stamp paper by any Central / State Govt. / Public Sector Undertakings / Autonomous Bodies under Central/ State Govt. of India.
- V. The bidder must have experience of executing similar orders during last three years ending March 2024.
  - Similar work means in execution & supply of Radio Pharmaceutical Products.
  - Bidder should have valid registration & permission/ NOC of AERB.
- VI. The Director reserves the right to carry out capability assessment of the Bidders and the Institute's decision shall be final in this regard.

#### 2. Rates and Prices

Bidders should quote the rate in the format given at Annexure. Incomplete bids will summarily be rejected. Rates quoted shall be firm and any variation in rates or terms during validity of the offer shall result in forfeitureoftheEMD/disqualificationofthebidder.

#### 3. Terms of Payment

- Shall mean 100% payment to the supplier on 30th day from the submission of the bill after receipt of goods in good & satisfactory condition and the pre-receipted bills to be submitted in triplicate with necessary information; however, the following options are available to the successful Bidder:-

**Option 1.** All suppliers who allow 4% trade discount will be made payment within 3 days it submits the bill with the stores department.

**Option 2.** All suppliers who allow 2% trade discount will be made payment within 7 working days of the submission of the bill with the stores department.

**Option 3.** Those suppliers who do not wish to avail the opportunity of early payments will be made payment on the 30th day of the submission of the bill with the stores department.

- Bill should be submitted with the stores department before 1.00 p.m. otherwise bill will be deemed to be submitted on the next working day.
- The supplier will have to specifically mark the option it wants to exercise on the bills. In case no option is exercised, it will be deemed that the supplier does not intend to avail early payment facility and the payment will be made to the supplier on 30th day from the submission of the bill.
- Payment will be released only after receipt of 100% supplies of the order against Tax Invoice by NEFT / RTGS.
- Any other conditions related to delivery of goods to be adhered to as mentioned on supply order.

#### 4. Termination

The Director reserves the right for termination of the contract at any time by giving one month written notice, if the services are found unsatisfactory and also has the right to award the contract to any other agency at the cost & risk of the successful bidder and excess expenditure incurred on account of this will be recovered by the Institute from Security Deposit or pending bills or by raising a separate claim.

#### 5. Performance Guarantee

The successful bidder shall submit the performance bank guarantee of the amount Rs 50,000.00 (Rs. Fifty Thousand) within 10 days of from the date of acceptance of the bid, to be valid for a period of 36 months from the date of issue of the Rate Contract/LOA. The payment will not be released without submission requisite valid performanceguarantee. The performanceguarantee can be by way of Bank Guarantee the prescribed format from any Scheduled Commercial Bank having its branch at Lucknow or in the form of Bank Draft in favour of "Director Dr. RMLIMS- IRF Society".

#### 6. Arbitration

If any dispute (s) or difference (s) of any kind whatsoever arise between the Parties (Institute and Contractor), the Parties hereto shall negotiate with a view to its amicable resolution and settlement through a committee appointed by the Director of the Institute.

In the event no amicable resolution or settlement is reached between the parties (Institute and Contractor) within 30 days after receipt of notice by one party, then the disputes or differences as detailed above shall be referred to and settled by the Sole Arbitrator to be appointed by the Director of the Institute.

Notwithstanding the existence or any dispute or differences and/ or reference for the arbitration, the Contractor shall proceed with and continue without hindrance the performance of the work under the contract with due diligence and expedition in a professional manner and the payment due to the Contractor shall not be withheld on account of such difference of arbitration proceedings unless such payment is a subject matter of the arbitration.

The arbitration proceedings shall be in accordance with the prevailing Arbitration and Conciliation Act, 1996 and Laws of India as amended or enacted from time to time.

The venue of arbitration shall be Lucknow, UP. The fee & other charges of Arbitrator shall be determined by the Arbitrator in terms of the Act and shall be shared equally between the parties. The Arbitrator will give the self-speaking and reasoned Award.

#### 7. Force Majeure

In the event of either party being rendered unable by Force Majeure to perform any obligation required to be performed by them under the contract, the relative obligation of the party affected by such Force Majeure shall be suspended for the period during which such cause lasts.

Theterm"ForceMajeure"asemployedhereinshallmeanactsofGod,War,CivilRiots, Firedirectly affecting the performance of the Contract, Flood and Acts and Regulations ofrespectivegovernmentofthetwoparties, namely the Institute and the Contractor. Upontheoccurrenceofsuchcauseanduponitstermination, the party alleging that it hasbeenrenderedunableasaforesaidthereby, shall notify the other party inwriting, the beginning of the cause immediately amounting to Force Majeure as also the ending of the said clause by giving notice to the other party within 72 hours of the ending of the cause respectively. If deliveries are suspended Force Majeure conditions, the by Instituteshallhavetheoptionofcancellingthiscontractinwholeorpart athisdiscretion without any liability athis part.

- All matters connected with this shall be governed by the Indian law both substantive and procedural, for the time being in force and shall be subject to the exclusive jurisdiction of Indian Courts at Lucknow.

  - **8.** Failure to furnish all information required and/ or false/ incorrect information and/or submission of bid not substantially responsive to the bidding documents in every

- **9.** The bidder must comply with the tender specification and all terms & condition of contract. No deviation in terms & condition of the contract shall be entertained unless specially mentioned by the agency/ bidders in the bid and accepted by the Institute.
- **10.** The bidder will be responsible for compliance with all Central and State laws as per rules / regulations / by elaws and order of the local authorities and statutory bodies as may be inforce from time to time during the contract period.

#### 12. <u>Definitions</u>

In this tender document, the words used in will have the meaning / definition / expressions herein after.

- **12.1** <u>Institute</u>: means Dr. Ram Manohar Institute of Medical Sciences, Vibhuti Khand, Gomti Nagar, Lucknow, U.P. (India).
- 12.2 <u>IRF:</u> means the department who is responsible & accountable for the purchase & supply of all lab consumables, which includes all activities right from materials requirement planning, Indenting, forecast, procurement, storage, receipt, inspection, distribution, issue of goods, realization of cost and the payment of goods to the suppliers as per payment options.
- **12.3** <u>Competent Authority</u>: means the Director of the Institute or any other authority to whom the relevant powers are delegated.
- **12.4** Contracting Authority: shall mean designated officer acts on behalf of the Director.
- **12.5** <u>Bidder</u>: shall mean any reputed & genuine manufacturer or authorized Indian agent to act in their names. The person, firm or company who submits the bid or the contract is made.
- **12.6** <u>Manufacture</u>: means producing, making, extracting, altering, furnishing or otherwise processing, treating or adapting any goods.
- **12.7** <u>Importer</u>: means the dealer who makes the first sale of such goods after imports in India.
- **12.8** <u>Dealer</u>: means any person who carries on in Uttar Pradesh the business of buying, selling, supplying or distributing goods directly or indirectly. Every person who acts within the State as an agent of a dealer residing outside the State and sells, supplies or distributes the goods in the State or acts on behalf of manufacture / importer.
- **12.9** RateContract: -Includes the notice inviting tender, general terms & conditions, definition & interpretations, instructions to Bidder, bid acceptance and submission of declaration forms. The Rate Contract will be made on Rs. 100/- non-judicial stamp paper.

#### 12.10 Situations for punitive actions against successful Bidder/dealer

- Unless and otherwise specified in the supply order, award of the contract, the ordered price will remain firm & fixed and will not be subject to escalation. The Institute reserves the right to cancel the SO or part thereof & reserves the right to revise the contract wholly or in part by a written notice to vendor, if: -
- The vendor fails to comply with the terms & conditions of the supply order.
- The vendor becomes bankrupt or goes into liquidation.
- The vendor does not replace the rejected goods on demand / request.
- The vendor fails to deliver the goods in time.
- The vendor does not replace the returned goods.
- **12.11** <u>Inspection:</u> means inspection carried out by the person specified in the contract.

- **12.12 Purchaser:** means the authority accepting the tender.
- **12.13** <u>Utilization:</u> means where the vendor keeps the track of their items required & consumed.
- **12.14** <u>Vendor Managed Inventory (VMI):</u> means when the vendor keeps the approved goods at his Fee & risk on request.
- **12.15** Test: means such tests as are considered necessary.
- **12.16 Unit:** means the unit of purchase as specified in the schedule of goods.
- 12.17 Tax Invoice: where the GST has been paid on the purchase of goods by the Institute's IRF and such goods have been sold / used in the Institute, the amount of tax paid to the vendor on the purchase of such goods shall subject to input credit of tax paid on the purchase or sale of goods under the rules. The vendor / authorized billing agency shall provide the tax invoice for availing the tax input credit.
- **12.18 Quoted & accepted rate:** means the rates quoted in tender bid & same is accepted by the Institute.
- **12.19 Tax:** means a tax is payable under GST.
- **12.20 Turnover:** means the aggregate amount for which goods are supplied or distributed by way of sale or are sold in any accounting or financial year.
- **12.21** Rate of tax: means the tax payable by the Institute under GST at the point of purchase of goods.
- **12.22** Exemption from Tax: means no tax under GST is payable at the time of purchase or supply of goods.
- **12.23** <u>Custom Duty:</u> means the duty is levied when the goods are imported under the rules.
- **12.24 F.O.R. destination:** means the goods will be delivered at Dr RMLIMS, Lucknow.
- **12.25** Force Majeure Clause: means offers are often subject to Force Majeure Clause by which it is meant causes beyond reasonable control such as war, invasion, civil disobedience, strike, lockouts, fire, flood, earthquake etc.
- **12.26** <u>Proprietary Articles:</u> means those items manufacture, production or sale are controlled by exclusive rights under patient Laws.
- **12.27** Evaluation of Bid: Identification of comparable products (Items) would be done by the nominated committee and the recommendation of the Committee would be final.
- **12.28** <u>Acceptance of Bid:</u> Shall mean communication for opening of financial bid to the tender.
- **12.29** Supply Order: Shall mean an order for the supply of goods at approved rates.

- **12.30** Work Order: Shall mean an order for installation of maintenance free laboratory equipment at no Fee basis against the supply & purchase of reagent & chemicals.
- **12.31** Power to extend the delivery period: means Director / Chairperson (IRF) is competent to extend the delivery period of the ordered goods in the larger interest of patient care & services.
- **12.32** <u>Successful Bidder:</u> Shall mean the person, firm or company with whom the contract is made by IRF Cell on behalf of the Director of the Institute.
- 12.33 Contract: means where two or more persons have a common intention communicated to each other to create some obligation between them, then it is said to be an agreement and enforceable by law. It includes notice-inviting tender, general terms & conditions of NIT and submission of declaration forms and agreement entered between the successful bidder and on behalf of the Institute.
- 12.34 Procurement on supply order basis: Supply of material covered under the rate contract will be made on the basis of written supply order with terms and conditions mentioned therein. It will be the responsibility of supplier to have an access with IRF to maintain the optimum inventory level. This has been decided to tide over the problem of over stocking including near expiry / slow moving / non-moving items, for which following mechanism will be observed: -
  - (i) Besides having liaison with user department, you are allowed to obtain information to know the consumption pattern / reports of the items concerned.
  - (ii) In hand stock position at IRF Store, IRF or peripheral sub stores of the department can also be obtained.
  - (iii) Information from IRF Stores to know the status of expiry / slow moving / non-moving products.
  - (iv) Company will own the responsibility of overstocking & expiry.
  - (v) Company will actively take preventive measures and inform Member Secretary (IRF)/Nodal Officer (IRF)/Chairman (IRF)/Director in writing about any specific item / quantity mentioned in supply order that may lead to overstocking / expiry.
- 12.35 In case of any difficulty in getting the feedback from IRF stores or peripheral departmental stores, they may contact Member Secretary (IRF)/Nodal Officer (IRF)/Chairman (IRF)/ Director.
- **12.36 Delivery**: All supplies will be delivered at the Department of Nuclear Medicine Dr RMLIMS, Lucknow Uttar Pradesh.
- **12.37** <u>Delivery time</u>: As mentioned in the supply order will be the essence of the order or contract. No variation will be permitted without prior authorization in writing, from the competent authority.

- **12.38** <u>Bid/ Rate:</u> Will mean the rates quoted by the Bidder will remain firm and fixed until the completion of Rate Contract.
- All rates quoted must be for One Unit (figures & words both). Price bid will be evaluated based on unit cost.
- Bids must be neatly typed before uploading.
- All rates quoted must be F.O.R. destination that is Dr RMLIMS, Lucknow.
- The Institute will not own responsibilities for clearance of any consignment.
- No escalation in rates except Govt. levy / tax would be permissible during currency of Rate Contract.
- No blank space should be left while mentioning Price bid.
- Bidder must take care that the rate and amount are written in such a way that interpolation is not possible in the Price Bid.
- Alteration if any must be attested by the Bidder.
- Conditional price bids would not be entertained and considered invalid. For example,
  - Ten percent discount if all quoted products are procured.
  - Ten percent discount on items 'X' if item 'Y' is also procured from this firm.
  - Ten percent discount on item 'X' if total qty. purchased exceeds a particular amount.
- The prices quoted by the Bidder will not in any case exceed the controlled price, if any, fixed by Central / State Government and Maximum Retail Price (MRP).
- Bidder must ensure that the quoted rates are exclusive of applicable GST.
- All rates quoted must have with due clarity of taxes as applicable along with mention of applicable GST and HSN code separately.

## 13. Fall Clause

Shall mean, if at any point of time or during the execution of the contract, the contractor reduces the sale price or offers to sell such stores, as are covered under the contract of IRFCell, to any person / organization including the purchaser or any department of Central / State Government at a price lower than the price chargeable under the contract, he / she will forthwith notify such reduction or sale or offer of sale to the purchaser and the price payable under the contract for the stores supplied after the date of coming into force of such reduction or sale or offer of sale will stand correspondingly reduced. In no circumstances, the rate will exceed the lowest price and in the event of price going down, the rate will be amended. Further the Rate Contract holder it registers at GeM Portal during currency of Rate Contract will have to intimate IRF instantly & immediately. Failure to do may invite severe action as deemed appropriate by the Institute IRF.

#### 14. Validity of Bid

The bid should remain valid for a period of 365 days from the date of submission of bid. Any bid valid for a shorter period shall be rejected as non-responsive bid.

#### 15. Scope of Work

The Scope of Work shall be as per requirement of the Institute as mentioned in Scope of Work.

#### 16. Submission of Offer

The bidder should submit their e-Bid duly signed and stamped on each & every page by the authorized Signatory.

#### 17. <u>Disqualification of Bidder:</u>

- Late receipt or submission of bid document will not be accepted & considered.
- Any action on part of the Bidder to influence anybody of the Institute will make his / her tender liable for rejection.
- Non-compliance of any of the terms & conditions of e-Tender notice would entail automatic/implied cancellation of bid.
- The Director is not bound to accept the lowest offer or any bid or to give reasons thereof.

#### 18. Acceptance of the Bid

The Institute does not bind itself to accept any bid and reserves the right to:

- Reject any or all offers with/without any reason
- Accept any offer of bidder without assigning any reason
- Reduce or extend the period of contract without assigning any reason.
- Accept any offer of bidder who is capable to handle the requirement.

#### 19. Award Criteria

The Institute will award the contract to the successful bidder whose offer has been determined to be responsive to all the conditions of the contract and meet the qualification & requirement of the Institute.

- 20. <u>Techno-Commercial Deliberation</u> Will become necessary in purchasing or finalization of the terms & conditions of the contract. It may either be in settling the price of materials other than the basic price of the contract or it may relate to various terms & conditions such as performance, after sales services, annual requirement, maintenance of stock, terms of payment, handling & clearing of the consignment from customs, inspection & testing.
  - **20.1** The vendors at the time of negotiation should provide supply order copies of Govt. Institute, Hospital in support of the offer.
  - 20.2 Techno-Commercial Deliberation is generally held to explore the possibility and finalizations of its details. It is also based on logic and attempt to arrive at reasonable agreement. But the basic cost of the goodsare neither negotiable nor permissible unless the position of lowest Bidder is finalized by the committee of the Institute, however remaining terms & conditions are completely negotiable with lowest quoting firms. It is order of the day also.

#### 21. Awarding Rate Contract:

- RC will be awarded to the principal firm with a copy to authorized dealer, if any.
- Supply of goods can be accepted through their authorized dealer or distributor
  against their authority letter provided that it was signed by the proper authority of
  the company / firm. However, it will be the sole responsibility of the principal
  company to ensure the supplies should be well within the delivery period.
- More than one rate contract or work order may be issued for similar item.
- The Institute will enter into rate contract with successful Bidder for a period of two year.

- The Director reserves the right to accept or reject the bid in part or full without assigning any reason. Director is not bound to accept the lowest offer or any bid or to give reasons thereof.
- During the currency of Contract if Rate Contract registers itself on GeM Portal for any products covered in Rate Contract during currency of Rate Contract, the same should be intimate to IRF within 30 days.
- 22. <u>Liquidated Damages:</u> means a term used in respect of contract for supplies. The time for and rate of delivery is considered as the "essence of contract". If a contractor / supplier fails to supply the material at the time for and rate of delivery, stipulated in the supply order then the purchaser, under the provision of standard conditions of the rate contract, shall have the right to recover "Liquidated Damages", In other words, it is a penalty payable by the supplier for his failure to deliver the goods in time. A penalty of 1% of value of orders per week will be imposed on delayed supply subject to a maximum of 10% of value of the orders. Value of order would be proportionate to the staggered schedule of supply, as mentioned in the respective supply order. Delivery shall be reckoned from the date of supply order.
- **23.** <u>Authority to the purchase: -</u> Any officer designated by the Institute shall be entitled to exercise all the rights and powers given in the contract.
- **24.** Responsibility of the successful Bidder for executing the contract: The successful bidder shall execute the contract in all respect in accordance with the terms and conditions mentioned therein. The goods whether in the possession or under control of his agents or servants or a carrier or in their joint possession, the successful bidder shall remain responsible until the actual delivery of the goods is made to the consignee at the stipulated place within the stipulated time as quality of goods and timely delivery are the essence of contract.
- 25. Penalty Clause: -Non-execution of supply order: If any vendor fails to supply within stipulated period and if the IRF (Purchase) has to buy the items from any other available source even at higher rate, the difference of amount will be recovered from the RC holder or his distributor. The amount of penalty will be deducted from the forthcoming bills of the supplier pertaining to any product.
